# **CONTAINER HANDLING CHARGES**

The terminal charges DO NOT include VAT!

Handling of certain goods at the terminal has become restricted. The valid list of banned and of a limited terminal-stay-assigned, hazardous and non hazardous substances is available on our website (<u>https://railcargobilk.hu/en</u>), under the *Downloads / Restricted and banned substances*.

In case of restricted dangerous goods, the terminal specifies a maximum of 24 hours for road delivery / rail dispatch regarding loaded units and a maximum of 48 hours for empty, but ADR/RID contaminated containers. Hazardous consignments in transit traffic are not affected by this measure.

PLEASE NOTE: If the volume of enlisted restricted dangerous goods reaches a critical level on the terminal, we reserve the right to restrict the acceptance of units containing these goods until such restriction is revoked.

Handling of any train is available only with an undersigned/valid operator agreement between the operator of the train and the terminal.

## 1. Storage charges

Legal deadline of temporary storage is set for 90 days (Article 144-149 UCC). In case of exceeding temporary storage deadline, Rail Cargo Terminal - BILK Ltd. will not be held accountable for any financial and customs regulatory consequences.

#### 1.1. For import containers:

On the day of arrival of the import train and the first four (4) calendar days are cost free.\*

After the cost free storage period the storage charges for the next four (4) calendar days:

containers (20'- 45'):	<b>17,00- €</b> / TEU** / day	
other combined freight units:	<b>32,00- €</b> / unit / day	
Storage charges after the four days period for the next consecutive two (2) calendar days:		
containers (20'- 45'):	<b>35,00- €</b> / TEU / day

Storage charges after first 6 (4+2) days period and there after:		
containers (20'- 45'):	<b>52,50- €</b> / TEU / day

\* The cost free storage period does not include the following national/public holidays: (January 1, March 15, April 2, April 4-5, May 1, May 23-24, August 20, October 23, November 1, December 25-26).

\*\* **TEU (Twenty-Foot Equivalent Unit):** 20' container counts as 1 TEU, 21'-30' container counts as 1,5 TEUs, 40' container counts as 2 TEUs, 45' container counts as 3 TEUs).



#### 1.2. Hazardous goods, including the empty but ADR/RID cargo contaminated units

5 calendar days from the area of the terminal due to effective regulations.

On the day of arrival of the import train and the following first calendar day are cost free\* After the cost free storage period the storage charges:

The cost shall be charged, in case of dangerous goods leakage detected at the territory of the terminal and eliminated with the involvement of the competent authority, inasmuch as the incident is caused by filling/loading fault or due to the technical condition of the intermodal unit.

#### **1.3.** Terminal storage fee (in case of containers arriving and departing by road):

#### The service is available only for normal, non dangerous goods containing units.

On the day of arrival of the unit and the following first calendar day are cost free.

After the cost free storage period:

## 4. Container repairing charges

In case of ordering repair services, please calculate with least two (2) lifting fees (from stock to repair yard and back to stock).

# 5. Reefer container service charges

#### 5.1. Moving container within the terminal:

This price includes the moving of import container to the reefer yard. In case of export containers the price include the unloading from the truck to the reefer yard.

#### 5.2. Handling charges:

First 24 hours:

In case of 24 hours exceeding cooling, per started calendar day: **40,00- €** / cntr/day

These charges include the plug in and plug off procedures, the inspections, the storage and used electricity cost.

# 6. Depot of empty containers

In case of empty units delivering trains (both in export and import traffic), the terminal requires an undersigned/valid operator agreement between the operator of the train and the terminal!

# 7. Label replacement charges regarding dangerous goods

We would like to call to your attention, that in case of dangerous intermodal units, the terminal is obligated to follow the legal requirements, including the labeling of the units (178-179/2017 (VII.5.) Government Regulation). In accordance with this regulation proper labeling is automatically performed.

\* In case of label replacement, the price of the relabeling already includes the cost of the label removal.
