Container handling charges

The terminal charges do not include the VAT!

1. Storage fees

Legal dedline of temporary storage is 90 days. In case of expiry of temporary storage deadline,
Rail Cargo Terminal – BILK Ltd. will not be held responsible for any financial and
regulatory consequences.

1.1 For import containers:

The day of arrival of the import train and the first four (4) calendar days are free of charges*

After the free storage period the **storage charges for the next four (4) calendar days:**

containers: 15,00- € /TEU**/day

other combined freight unit: 29,00- € /unit/day

Storage charges after the four days period for the next two (2) calendar days:

containers: 33,00- € /TEU/day

other combined freight unit: 65,00- € /unit/day

Storage charges after the two (2) days period:

containers: 50,00- € /TEU/day other combined freight unit: 100,00- € /unit/day

1.2 For ADR/RID containers (including the empty but ADR/RID cargo contained containers) +50% surcharge.

The day of arrival of the import train and the first two (2) calendar days are free of charges*

The units contain flammable or explosive materials are to be removed within 5 calendar days from the area of the Terminal due to prevailing regulations.

1.3 Terminal storage fee (in case of arrival and departure by road):

The day of arrival of the unit and the first calendar day are free of charge. After the free storage period:

containers: 26,00- € /TEU/day other combined freight unit: 51,00- € /unit/day

^{*} The free storage period do not include the following national holidays (1st January, 15th March, 19th April (Good Friday), 21st-22nd April (Easter), 1st May, 9-10th June (Pentecost), 20th August, 23rd October, 1st November and 25-26th December).

^{**} TEU: Twenty-Foot Equivalent Unit (e.g. 1×20' container counts 1 TEU, 1×21'-30' container counts 1,5 TEUs, 1×40' container counts 2 TEUs, 1×45' container counts 3 TEUs).

2.2 Mounting charges of swap bodies mounted on feet: 26,00- € /lifting

3. Container cleaning fees

Only by special agreement

4. Container repairing fees

4.1 Container repair service Only by special agreement

4.2 Container repair man-hour: 30,00- € /started hour

5. Reefer container service charges

5.1 Operation on the terminal:

43,00- € /cntr

This price contains the moving of import container to the reefer yard. In case of export container the price contains the unloading from the truck to the reefer yard.

5.2 Handling charges:

First 24 hours: 37,00- € /cntr/day

From 25th hour per started day: 37,00- € /cntr/day

These charges include the plug in and plug off procedures, inspections, and the storage and energy costs.

5.3 Handling charges of Gen-Set:

Only by special agreement

7. Swap bodies handling charges

Handling charges of swap bodies on terminal: 26,00- € /handling

Storage of swap bodies on terminal: 3,00- € /day/unit

8. Label replacement
